Surface Preparation

General:

All surfaces must be cured, firm, dry and cleaned free of loose paint, dust, dirt, oil, grease, wax, chalk, rust, mildew or any other contamination or condition that would adversely affect the performance of the coating.

Application: Brush, Roll, or Spray

Brush: Use synthetic bristle brush.

Roller: Use roller nap appropriate to surface profile.

Spray: For airless sprayer use .013 - .017 spray tip. For HVLP or Conventional sprayers please consult sprayer manual for latex paints.

Do not apply when material, air, and/or surface temperature is below 50°F or above 90° F. Stir thoroughly before and during use. Maintain a wet edge to avoid lap marks.

Store at room temperature. Keep from freezing.

Thinning

Thin with clean water to desired consistency. Recommended rate for marking pallets is 3 parts water to 1 part 341-104 Blue Concentrate. When diluted at this rate the Coating VOC remains constant while the Material VOC is changed from 4.7 grams per liter to 1.2 grams per liter, approximately.

Precautions

Avoid contact with eyes, skin and clothing. Do not take internally. Wash thoroughly after handling. Close container after each use. For additional safety information consult the Material Safety Data Sheet for this product.
